We would like to inform you about the COMPETITION PROGRAM and the applicable DEADLINES for the **2026 IWF World Youth Championships** to be held in **Cali, Colombia**.

COMPETITION TIMELINE

- **05 APRIL 2026** / PRELIMINARY ENTRY / WHEREABOUTS DEADLINE (Q2)
- **05 JUNE 2026** / DEADLINE FOR FINAL ENTRY / PAYMENT OF FEES & SUBMISSION OF FORMS
- **30 JUNE 2026** / WHEREABOUTS DEADLINE (Q3)
- **22 JUNE 2026** / VERIFICATION OF FINAL ENTRIES (ONLINE)
- **05-11 JULY 2026** / IWF WORLD YOUTH CHAMPIONSHIPS (7 DAYS)

IMPORTANT

IN ACCORDANCE WITH THE IWF TCRR, IT IS MANDATORY FOR ALL ATHLETES TO REGISTER BEFORE THE PRELIMINARY ENTRY DEADLINE FOR THE IWF WYC.

For this purpose, you can now register up to **16 ATHLETES / GENDER**, even though the final number of competitors can only be a maximum of 8 athletes (+2 Reserves) per gender, which you shall select by the Final Entry deadline.

ENTRIES CAN ONLY BE REGISTERED VIA THE **IWF ONLINE ENTRY SYSTEM** AT

Please ensure that all your athletes are included in the preliminary registration, as **AFTER 05 APRIL 2026 NO ADDITIONAL ATHLETES CAN BE REGISTERED.**

By 05 JUNE 2026, participating Member Federations **MUST transfer 100% of the total amount (ACCOMMODATION & ENTRY FEES)** to the Organizing Committee.

Member Federations that fail to comply with this deadline may be declared ineligible in the competition.

ELIGIBILITY

- In accordance with Article 5.5.16 of the IWF Anti-Doping Rules, the whereabouts information of the athletes shall be submitted **at a minimum of three (3) months** prior to the IWF World Youth Championships (IWF WYC).
- Athletes who wish to compete at the IWF WYC shall submit their whereabouts information for the period outlined above at the latest on **05 APRIL 2026**.

- ADAMS Deadline for **Q2 2026** in regards to the IWF WYC: **05 APRIL 2026**
- ADAMS Deadline for **Q3 2026** in regards to the IWF WYC: **30 JUNE 2026**

In case of failure to provide the whereabouts information by the Member Federations, the respective Athlete(s) for whom the whereabouts have not been submitted **shall be automatically ineligible to compete at the IWF Event in question.**
