

IWF PRIVACY NOTICE

Who we are

This Privacy Notice serves to outline how the International Weightlifting Federation (“IWF”) collects, uses, discloses, and protects the personal data of individuals (“Data Subjects”) in accordance with the General Data Protection Regulation (EU) 2016/679 (“GDPR”) and the Swiss Federal Act on Data Protection.

Throughout this Privacy Notice, the term “Personal Data” means information relating to an identified or identifiable individual (i.e. a natural person). This can be information that directly identifies you or information that can be used to identify you when combined with other data. This Policy applies to the collecting or processing of your Personal Data in accordance with the applicable data protection laws and regulations.

The IWF is committed to respecting and safeguarding your privacy and ensuring that your personal data is processed transparently, fairly, and lawfully.

What personal data do we collect?

Depending on your relationship with us, we may collect:

- Identification data (name, nationality, date of birth, gender)
- Contact data (email, phone number, address)
- Membership and licensing information
- Sports performance data (rankings, results, biometrics, anti-doping related data)
- Financial data (bank details, invoices)
- IT data (IP address, cookies, logs)
- Images, videos, or voice recordings during events
- Special categories of data (e.g., health data) are processed only with explicit consent or under strict legal requirements.

Legal Bases for Processing

Depending on the purpose of the processing, the use of your Personal Data is premised on the following legal bases:

- Necessity for performance of a contract;
- For compliance with legal obligations;
- Based on our legitimate business interest;
- Legitimate reasons of public interest, where applicable; or
- Based on your consent.

How long do we keep your data?

Only as long as needed for the purpose collected or required by law.

What are your rights?

You have the following rights under the applicable laws and regulations:

- Right to access your personal data
- Right to rectification
- Right to erasure (“right to be forgotten”)
- Right to restrict processing
- Right to data portability
- Right to object to processing
- Right to withdraw consent at any time
- Right to lodge a complaint with a supervisory authority
